**ROYAL BOROUGH OF WINDSOR AND MAIDENHEAD
DEFINITIVE MAP AND STATEMENT**

THE FOOTPATH 15 WINDSOR MODIFICATION ORDER 2014

This Order is made by the Royal Borough of Windsor and Maidenhead under Section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act") because it appears that the Royal Borough of Windsor and Maidenhead Definitive Map and Statement require modification in consequence of an event specified in Section 53(3)(b) and Section 53(3)(c)(i) of the Act, namely the expiration of any period such that the enjoyment by the public of the way during that period raises the presumption that the way has been dedicated as a public path and the discovery of evidence which, when considered with all other relevant available evidence, shows that a right of way which is not shown on the Map and Statement is reasonably alleged to subsist in the area to which the Map relates.

The Authority has consulted with every local authority whose area includes the land to which the Order relates.

The Royal Borough of Windsor and Maidenhead hereby orders that:

1. For the purposes of this Order the relevant date is 17th April 2014
2. The Royal Borough of Windsor and Maidenhead Definitive Map and Statement shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Footpath 15 Windsor in the Royal Borough of Windsor and Maidenhead Order 2014.

PART I

MODIFICATION OF THE DEFINITIVE MAP

(References to lettered points in the following description are references to letters on the attached map showing the path being described. All distances and directions are approximate.)

DESCRIPTION OF PATH OR WAY TO BE ADDED

FOOTPATH 15 WINDSOR

The path commences at point A on the edge of the adopted highway between properties 161 and 163 Oxford Road, Windsor (Grid Reference 496068 176831) and runs in a generally southerly direction for a distance of 52 metres to point B between properties 26 and 25B Clewer Fields, Windsor (Grid Reference 496070 176779).

The width of the path throughout shall be recorded as: 1.22 metres (A-B)

PART II

MODIFICATION OF THE DEFINITIVE STATEMENT

FOOTPATH 15 WINDSOR

The description of the path shall be:

"From": Oxford Road between property numbers 161 & 163.

"To": Clewer Fields between property numbers 25B and 26

The width of the path throughout shall be recorded as: 1.22 metres (A-B)
