1. Children who are looked after and previously looked after children, including children who were previously looked after outside of England
2. Children with exceptional medical or social reasons for requiring the school
3. Children of staff in either of the following circumstances:
  - a. The member of staff has been employed at the school for two or more years at the time of application; *and/or*
  - b. The member of staff is recruited to fill a vacant post for which there is a demonstrable skills shortage
4. Children living in the designated area of the school and who would have a sibling at the school at the time of admissions for whom a place is sought
5. Children who live in the designated area of the school
6. Children would have a sibling at the school at the time of admission of the child for whom a place is sought
7. All other applicants

**Tiebreaker 1** – (applies to categories 4 and 6) Preference will be given to siblings of students in the learning Support Centre, who will be allocated places before other siblings.
